Biblical Lifestyle Statement

Hughson Christian School is a religious, nonprofit organization representing Jesus Christ throughout the local community. Staff members and volunteers of Hughson Christian are committed to living a life that is set apart and brings honor to the name of Christ.

Employees at Hughson Christian are committed to the mission of the school and to living in a manner that brings glory to the name of our Lord; to serve with each other in a way that honors God, promotes authentic relationships, and moves Hughson Christian forward in accomplishing its mission. A Christian lifestyle should reflect the Biblical perspective of integrity, appropriate personal and family relationships, business conduct, and moral behavior.

Hughson Christian requires its employees to be born-again Christians, living their lives as Christian role models (Romans 10:9-10, 1 Timothy 4:12, Luke 6:40)

Hughson Christian employees are expected to demonstrate a teachable spirit, an ability to share love for others, a willingness to live contentedly under authority, and a commitment to follow the Matthew 18 principle when an issue arises with fellow employees or management.

Hughson Christian believes the term "marriage" has only one meaning: the uniting of one man and one woman in a single, exclusive covenant union, as delineated in Scripture, (Genesis 2:18-25) and that God intends sexual intimacy to occur only between a man and a woman who are married to each other as commanded by God. (Genesis 1:27-28; 2:21-24; Matthew 19:4-9; Mark 10:5-9; Ephesians 5:22-33).

Hughson Christian believes that men and women are born with gender identity assigned to them by God, and that rejecting one's biological sex is a sin. Individuals employed at Hughson Christian must accept their God-assigned biological sex (Genesis 1:26-28; Mark 10:6).

Employees at Hughson Christian are to maintain a lifestyle based on biblical standards of moral conduct and commit to not engage in behavior expressly forbidden in the Bible. This includes, but is not limited to, slander, drunkenness, stealing, profane language, gluttony, premarital sex, adultery, and homosexual behavior (1 Corinthians 6:9-11).

Hughson Christian employees must maintain a lifestyle based on biblical standards of conduct. Failure to do so may result in a reprimand or, in some cases, dismissal from employment.
